Regular Board Meeting Highlights March 14, 2024

## Financial Matters

• Alternative Medicine Program @ Perry Behavioral Health Choices (PBHC):

PBHC Director Theressa Kane presented a proposal for the creation of an Alternative Medicine Program that would bridge the gap between clinical and medical oversight. The proposal called for funds to support the addition of a clinician with a doctorate in alternative medicine, as well as the purchase of alternative medicine supplies.

Board members approved a \$10,000 allocation for the purchase of alternative medicine supplies — and an allocation of up to \$50,000 to support the addition of an alternative medicine clinician (through December 31, 2024). Board members will then review the history of productivity for this position.

Many alternative therapists assert that conventional medicine's treatment programs for addiction fail to support the body adequately as it withdraws from the once-steady presence of alcohol or other drugs. PBHC's Alternative Medicine Program will provide non-pharmacological supplements, comfort measures, behavioral modification, and clinical counseling.

- <u>Reconciliation Report</u>: Under the guidance of Finance/Audit Committee Chair Dr. Dan Scheerer, board members reviewed and approved the February 2024 Reconciliation Report that showed deposits, checks written for MHRS Board operations, payments to in-network contract service providers and out-of-network community partners, and journal entries.
- Other February Financial Reports: Board members also reviewed the following February 2024 fiscal reports: 1) Balance Sheet as of February 29, 2024; 2) Monthly Report of Funding Reserves; 3) a Year-to-Date Status Report for the MHRS Board's Operating Budget; 4) Contract Services Expenses; and 5) a Dashboard Report that provides a high-level overview of key fiscal indicators.
- <u>MHRS Board's Calendar Year 2025 Operations Budget</u>: Board members approved the MHRS Board's CY 2025 Operating Budget totaling \$1,187,033.88, representing a 4% increase over the CY 2024 Operating Budget.
- <u>Support Resolutions for Capital Projects</u>: Board members approved three capital project support/monitoring resolutions required by the Ohio Department of Mental Health & Addiction Services. These were for: 1) renovations to the Jeffersonian Building in Cambridge that will become Allwell Behavioral Health's Guernsey Counseling Center; 2) a Crisis Stabilization Unit for Youth at Genesis Behavioral

## Black Balloon Day — A Remembrance (Extracted from Perry County Tribune Article)

MHRS Board Director Misty Cromwell and Elaine Shuster, Associate Director, recently attended the 'Black Balloon Day' observance at Perry Behavioral Health Choices (PBHC) in New Lexington. This observance had three purposes: 1) a remembrance of those who died in 2023 as a result of an accidental drug overdose; 2) continuing education about drug prevention and detection; and 3) a strong belief that "people can recover."

To the right is one piece of the many artworks that adorned the reception room at PBHC. Lining the hallway on the way to the reception room were 14 pairs of shoes that signified how many Perry County residents died in 2023 as a



result of an accidental drug overdose. Perry County ranks 20<sup>th</sup> out of 88 Ohio counties for the highest overdose death rates based on preliminary numbers in 2023.

Parked outside PBHC was a trailer decorated on the inside as a miniature bedroom for a typical teenager. On the outside, the vehicle was identified as S.P.O.T., the Substance use Prevention Observation Trailer. Inside, guests could see all the secret places a teenager could hide a drug stash in seemingly innocent everyday items.

PBHC Executive Director Theressa Kane noted, "The driving motivation for Black Balloon Day is the staggering epidemic of drugs in Perry County." She pointed out that the observance is an opportunity to reach out to affected families, letting them know, 'We care."
